VISA APPLICATION FORM FOR ENTRY CLEARANCE INTO INDIA

FOR WHAT TYPE OF VISA THIS FORM CAN BE USED?

This application form can be used for all types of visa for short stay or long stay. You may apply for one type of visa only and fill up appropriate sections.

HOW MUCH DOES AN APPLICATION FORM AND A VISA COST?

This form is available free of cost. Visa for any duration is issued free of charge.

HOW MANY PEOPLE CAN APPLY IN ONE FORM?

Only one passport holder can apply in one form. However, you can include the name(s) of your children in your application if their name/names is/are endorsed in your passport and they will be travelling with you.

FILLING UP THE FORMS

Please complete the form in ink and write neatly in Block letters. You must answer all questions correctly and completely. Falsely providing misleading information may lead to refusal or cancellation of visa or penalties while in India. A representative may help you to fill up the Form but you must sign it.

SUBMISSION OF FORM

You or your authorised representative can submit your application directly at the visa counters of the High Commission of India, Dhaka up to 09.30 hrs on any working day (Sunday-Thursday). You can also send your passport for visa by mail.

WHAT SHOULD YOU PRODUCE ALONG WITH THE APPLICATION

(i) **General - Tourist/visit/Visa:**

- a) Your valid passport (with at least 6 months validity)
- b) Two recent passport size photographs
- c) Required US \$ endorsement or sponsorship certificate in lieu.

(ii) **Business Visa**

If you want visa for business purpose you are required to produce business papers including copies of business contract and letters of credit in support of your purpose.

(iii) **Visa on Medical ground**

If you are applying for visa on Medical ground, you are required to produce medical documents in support of the purpose.

(iv) **Transit Visa**

If you are applying for transit visa you are required to produce:

- i) Photocopies of confirmed air tickets along with the original ticket.
The original air ticket will be returned at the counter after scrutiny.
- ii) You should have obtained visa for the destined country before applying for transit visa.

(v) **Student visa:**

If you are applying for student visa, you are required to produce the following:

- i) Evidence of your admission to the Institute/Course.
- ii) Bonafide Certificate as a student if you are already pursuing studies in India.
- iii) No Objection Certificate from the Ministry of Education, Government of the People's Republic

of Bangladesh for your higher Studies in India.

iv) A guarantee from your parents/ guardian through the authorised bank to the effect that he/she has enough financial resources to support your studies in India and the bank will remfl on behalf of your pamntsfgoardian theinquired foreign exchange.

v) US\$ endorsement in your passport enough to support you in India for a period of 12 months.

vi) Photocopies of relevent academic certificates on the basis of which you are seeking admission or have been admitted in India.

CONDITIONS FOR ENTRY INTO INDIA

(Please read this section carefully)

Your visa application is liable to be rejected if you

Suffer from dangerous disease, such as, tuberculosis and AIDS. Suffer from mental illness. Are addicted to or have trafficked in narcotics. Have been convicted for or have criminal charges outstanding in any country. Have been deported or expelled from any county.

Even if you hold a valid entry clearance you can still be refused entry into India by the Immigration officer, if he is satisfied that:

- Your entry clearance was obtained by false representation or by concealment of relevant facts, whether or not you were aware of that fact.
- A change in circumstances between' the date of your application and your arrival in India it validates your entry clearance; or refusal is justified on the ground of' restricted returnability, medical. grounds, criminal record, because you are subject to a deportation order; your exclusion would be conductive to the public good.

ii) An immigration officer can ask anyone to be medically examined on arrival in India, if he considers necessary. If you intend to stay in India longer than' six months you could be required to have a medical examination before your entry clearance is issued.

iii) You must not 'undertake employment or formal study/research in India unless granted employment or student visa.

iv) You must leave India by the end of the authorized period of stay unless extended by appropriate authority.

v) There may be other conditions, depending on the purpose of your visit. These conditi6ns will be shown on your visa.
