**VISA FEE WILL NOT BE REFUNDED.**

**Visa Fee**

- NOK 100/- Transit (Normally issued for connecting flights)
- NOK 400/- Tourist (Maximum validity given is six months only)
- NOK 700/- Not applicable to Tourist visas (upto 1 year with double or multiple entries for Indian/Origin/Business people).
- NOK 750/- student visa valid for 1 year.
- NOK 1300/- 5 year multiple entry visa, if eligible. Only for People of Indian Origin with Norwegian citizenship.
- NOK 50/- Transfer of old visa to new Passport

1. Special permission is required for visiting restricted areas like Assam and Sikkim with additional fees.
2. **For BUSINESS visa, you must enclose a letter of Invitation from India and a Letter of Guarantee from your company or firm.**
3. Completed application/visum form must include : VALID PASSPORT, TWO PHOTOGRAPHS AND APPROPRIATE VISA FEE.
4. The Passport should be valid at least upto 3 months beyond the date of expiry of visa.
5. If you are travelling through any yellow fever endemic country, you should possess a valid yellow fever vaccination certificate before entering into India.
6. **If you are applying by post, please send the visa fee by cheque drawn in favour of Embassy of India, Oslo.** If you require us to return your passport by mail, enclose a self-addressed envelope with correct postage stamps under Rek/Registered post. Visa by post is subject to postal delays.
7. **Nationalities other than Norwegian are requested to contact this Embassy before submitting their applications. The fees are also different for those who are born elsewhere but holding Norwegian passport and held another nationality earlier.**
8. It normally takes 72 hours to obtain visa.

10. Delivery of serviced Passports: 1400-1600 Hr
11. **For Icelandic citizens, bank clearance charges are extra i.e.**
